The Covenant of Metabeing is the Philosophical foundation of the Metawisdom Civilization. It establishes the purpose, direction, and universal system of life values for all humanity.

- It establishes that the supreme purpose of every human being is to discover, develop, and actualize the potentials of Metabeing – the source of wisdom, virtue, and all other humanistic values.

- It establishes that the most rightful and effective path to the awakening of Metabeing is to unfold and cultivate Metawisdom within each individual, while simultaneously fostering and harmonizing Metawisdom among human beings to form humanity's collective Metawisdom field.

- It establishes that all forms and domains of societal activity from education, economics, healthcare, and culture to technology – are designed and operated with the highest purpose of serving the awakening and development of Metawisdom.

The Covenant of Metabeing initiates humanity's journey of awakening, affirming that genuine development does not lie in material or intellectual achievements, but in the realization of the most profound nature of the human being.

2. The Covenant of Edenearth

The Covenant of Edenearth is the Psychological foundation of the Metawisdom Civilization. It liberates the individual from internal conflict, removes obstacles between people, and dissolves the tensions created by obsolete dogmas.

- Advances in science and technology in general, and the triad of AI – Robotics – Automation technologies in particular, are sufficient to provide and guarantee a material foundation for all humanity; liberating human beings from competitive pressure and all forms of labor below the level of Self-awareness – Self-mastery – Self-volition. All people receive free provision at appropriate levels for basic needs: food, healthcare, housing, education, recreation, and personal maturity.

- Virtual reality technology is developed to a level that can safely, economically, and freely satisfy all needs at the physical, emotional, ego, and instinctual levels for everyone. Higher needs such as creativity, value expression, and transcendence are fulfilled through the forms of Consciousness labor – Metawisdom labor – Metabeing labor – characteristic of this civilization; aimed at nurturing, operating, governing, and developing the civilization itself.

- All people refrain from obstructing or judging one another, and willingly respect, facilitate, guide, and support each other in pursuing individual purposes, provided such purposes do not hinder or harm others, nor violate the principles of resource distribution or the value norms of the civilization.

The Covenant of Edenearth opens the path to a real, lived Eden on earth, wherein technology becomes a means of liberation rather than an instrument of constraint; wherein human beings live in safety, comfort, and material sufficiency, allowing them to reach toward spiritual richness.

3. The Covenant of Evolution

The Covenant of Evolution activates the mechanism of co-evolution, wherein each person's development becomes the momentum and means of support for others' evolution.

- Liberating the trapped Metabeing energy in others, for others, is the way to liberate Metabeing energy within oneself in a more sustainable, expansive, profound, and miraculous manner.

The Covenant of Evolution is the Moral foundation of the Metawisdom Civilization, wherein morality becomes the natural engine of personal development needs; wherein helping others is helping oneself, and progress in others becomes a source of momentum for one's own progress.

Unified Science, therefore, is not merely a new scientific discipline; it is the knowledge framework of the entire Metawisdom Civilization – wherein science returns to its sacred nature – as the unified language of Cognition, Self-mastery, and Creation.

2. The Metawisdom Economy

3. Liberatory Education and Training

4. Soul-Mind-Body Healthcare

Soul-Mind-Body Healthcare is the most comprehensive form of healthcare humanity can aspire to, built upon simultaneous breakthroughs in dimensions of cognition, biology, energetics, and Metabeing.

First, Soul-Mind-Body Healthcare affirms that each human being is a Metawisdom Subject, capable of existing as an Individuated Metabeing or a dynamic Metabeing. Therefore, care is not limited to the scope of physical body, psychology, or rational faculties, but extends to caring for Subjects in pre-incarnation and post-disincarnation states.

Therefore, its direction is to prioritize cultivating and liberating Metawisdom capacity, Metabeing capacity, helping each individual know how to autonomously direct these capacities and thereby care for themselves effectively, sustainably, and holistically.

Third, Soul-Mind-Body Healthcare does not deny previous forms of healthcare, but re-perceives those forms as interaction and support from outside. In other words, they represent the care and nurturing from the Universal Metabeing to the Individuated Metabeing. Therefore, both modern and traditional medical methods, when placed within the Metawisdom frame of reference, become more scientific, more effective, and more harmonious with the comprehensive process of care and recovery.

The feasibility of Soul-Mind-Body Healthcare is partially guaranteed by the system of Metawisdom Meditation Techniques, which the author has directly practiced, implemented, and trained in practice, including the Active Assimilation Technique and the Soul-Mind-Body Separation Technique.

These techniques enable individuals to activate, stabilize, and direct Metawisdom capacity and Metabeing capacity, thereby self-regulating the Physical – Psychological – Rational Consciousness dimensions in a sustainable manner.

The Metawisdom Meditation System can naturally integrate with empirical medicine to form a universal medical model, in which modern medicine provides external support while intrinsic Metawisdom serves as the central healing capacity.

The roadmap for developing and integrating Soul-Mind-Body Healthcare with modern medicine has been introduced by the author in the work “AI and the Metawisdom Civilization” as an implementation direction applicable at the individual, community, and national healthcare system levels.

5. Archetypal Arts

Archetypal Arts is the environment that connects, resonates, and cultivates humanity's shared humanistic values, wherein the primordial beauty of Metabeing is perceived, experienced, respected, affirmed, and expressed in a harmonious and natural way with human life.

Using Archetypal Materials

Archetypal Arts returns to the primal materials of nature, such as: the images, colors, movements, and sounds of earth, water, wind, and fire; and more broadly, plants, animals, space, light, and at its highest threshold – the tones of the human voice.

Archetypal Arts does not use human imagery or human language as a means of expression. Through this, it dissolves the boundaries between cultures, eliminates dependence on iconic forms, and minimizes the ostentation of human ego in modern art. In Archetypal Materials, beauty does not come through description or localized linguistic structures, but arises from the state of existence, direct resonance between human beings and the expansive and unified manifestations of life.

Liberating Archetypal Energy

The fundamental spiritual energies within human beings share similar qualities with the primordial materials of nature. Faith that is steadfast and immovable like earth; affection that is soft and flexible like water; emotions and thoughts that shift like wind; and will or aspiration that blazes like fire.

Through the primordial materials of nature, through the expressive capacity of the artist, and through the empathic ability of the recipient, Archetypal Arts can awaken and cultivate these inner spiritual energies within human beings in a natural, flexible, and stable manner.

And an important characteristic that must be mentioned is that Archetypal Arts allows these energies to be nurtured and animated within human beings without binding them to cultural symbols or specific ego forms – things that have already been commercialized, politicized, and shaped by ideological competition.

Shaping Archetypal Assets

To create a work of Archetypal Arts, the artist must listen to the movement of Metabeing within themselves, the needs and tendencies of inner movement in others, and the expressive nuances of materials in the natural world. This helps them cultivate and strengthen Metawisdom capacity and shape the Metabeing assets.

Similarly, for the recipients, they must also release dogmas and prejudices to open their heart to listen and receive the resonances of nature; they must sift within their own minds for appropriate experiences that allow them to vibrate with the artwork; and they must strive to listen to, explore, and follow the artist's streams of inspiration. This helps them gradually escape from the coagulations of the mind, open higher levels of inner expression, and align more deeply with the qualities of the Metabeing.
